Payment Terms:

Visa, MasterCard, Discover and C.O.D. shipments are accepted. Charge accounts may be applied for, by buyers wishing to establish an on-going business relationship, by completing a credit application. Approved open charge account terms are net 30 days.

Freight Policy:

Ordered items are priced F.O.B. shipping point. Freight charges will be added to the invoice. Our responsibility ends at the acceptance of the shipment by UPS, Federal Express or Common Carrier. Consignee must file claim for shortages and damaged freight against the shipping company if it occurs. Inspections should be made and any damages should be reported before the shipping company leaves consignee's premises.

Sales Tax:

For our taxable customers with orders shipping to OH, PA, WV or MD, we are required to charge tax by the SHIP TO state. If our customer is tax exempt, we are required to have a tax exempt certificate on file, otherwise we are required to charge tax for that order. On orders going to all other states, our customer is responsible for all sales or use taxes if applicable.

Return of Goods:

Prior authorization, within 45 days of purchase, is required before returning any item for credit. If authorized for return, freight charges must be prepaid by buyer unless otherwise noted by seller in the authorization to return goods. Customer ordering errors will be charged a minimum of 20% restocking fee. Returns for special ordered items are subject to manufacturer approval and any charges will be the responsibility of the buyer. All returns are subject to sellers' inspection and acceptance.

Warranty:

All equipment sold by Stanwade Metal Products, Inc. is subject to manufacturer warranty. Stanwade Metal Products will not allow claims for labor or consequential damage resulting from purchase, installation or misapplication of the product. Restocking, freight charges, etc. will be the responsibility of the buyer.

Catalog prices are subject to change without notice. Prices can be verified at the time of the order.
